Age Categories

- 7-10 years**
- 11-14 years**
- 15-18 years**

Entry Limitations

Please note the following entry rules:

- **One Entry per Child:** Each child is permitted to submit only a single piece of artwork to encourage diverse participation and ensure fair competition.
- **No Parental Assistance:** To promote originality and creativity, parents are not allowed to assist with the artwork. We want to see the children's natural abilities shine through without external influence.
- **Geographic Location:** It is important to note that entries for this competition are restricted strictly to applicants residing in South Africa.

Artwork Guidelines

- **No AI Generated Images:** To maintain authenticity and ensure that the art reflects the child's individual skill and style, we will not accept any AI-generated images. All submissions must be the child's own creation.
- **Size Restrictions:** Artwork must be **A4 or smaller** in size. This specification is designed to keep submissions manageable and uniform.

Judging Criteria

An esteemed panel of judges will evaluate the entries based on several criteria, including:

- **Creativity and Originality:** The uniqueness of the work and its ability to reflect the artist's vision.
- **Technical Skill:** The artist's proficiency in their chosen medium.
- **Theme Interpretation:** How well the artwork reflects the theme of the competition.

Ownership and Auctioning of Artwork

One of the most compelling aspects of the SAOA art competition is the commitment to philanthropy. Upon selection, the winning artworks across all categories will become the property of the SAOA. These masterpieces may be featured in an auction, with all proceeds going to a charity chosen by the SAOA.
